**GUIDELINES**

1. Spaces are assigned on a "first come-first assigned" basis. As soon as your registration form and fee are received you are assured a space (pending a committee review).
2. Booth space is limited. The fee for each 10'X15' booth is \$50. Make checks payable to JEFF DAVIS CADA.
3. CADA is not liable for any damages or loss of merchandise, artwork, crafts or injury to participating persons. Each participant must furnish insurance if desired.
4. The sale and/or display of guns or weapons is prohibited.
5. The designated area will be ready for setup at 7:00 A.M. on the day of the show.
6. Tents, chairs & tables are not provided. You must provide your own change for sales in your booth. Limited electric outlets can be provided for an added \$25.00 fee.
7. Vendors are allowed to drive to the booth area for unloading between 7 & 8:30 A.M. After unloading you must remove your vehicle to the parking area. BOOTHS MAY NOT BE DISMANTLED UNTIL AFTER 3 P.M. To do so would create a safety hazard to the public. Vendors are responsible for the cleanup & removal of their booth area.
8. Deadline to turn in entry forms with fees is March 16<sup>th</sup>. All fees (non refundable) must accompany this entry form.
